Sub: Issuance of Letter of Approval to medical examiners on DGS panel – reg.

There has been lot of enquiries from the existing empanelled medical examiners requesting for letter of approval in their name. During the initial period of approval, this Directorate placed the names of approved medical examiners on the DGS website without issuing formal letter of approval.

Now, the existing empanelled Medical Examiners who have not been issued with formal letter of approval are approaching the DG Shipping for such letters to confirm their status of approval. To overcome this, the Competent Authority has decided to streamline and regularize the empanelment process in respect of all the approved medical examiners.

In view of this, the empanelled medical examiners on DGS panel, who have not been issued with formal approval letter till date or letter of approval in the prescribed format as attached in the Annexure I, may apply to the DG Shipping by mail requesting for letter of approval. The application shall be made in their letter head with a request to issue letter of approval. The applicant shall include inter alia the following:

- 1. Date and year of approval.
- 2. Present age of the approved medical examiner (proof/evidence).
- 3. Date/year when he/she reaches the age of 65/75 years.
- 4. A copy of registration certificate issued by the concerned Medical Council.
- 5. Present postal address including email of the facility.
- 6. Declaration that periodical returns being submitted to D.G.Shipping.
- 7. 2 nos passport size photographs.(4.5 cm x 3.5 cm)
- 8. Declaration stating that no adverse report made by the ship owner/seafarers pending against the approved medical examiner.
- Declaration stating that no legal proceedings pending in any Indian/foreign court against the approved medical examiners.

10. Any other relevant information, if considered necessary.
