Sub: Issuance of Replacement/Renewal Sticker/Duplicate CDCs -reg.

The DG Shipping Order No. 06 of 2012 [F. No. 3(2) CR/ 2006] dated 04.12.12 has enabled the decentralization of an issuance of Continuous Discharge Certificate (CDCs) in the Govt. Shipping Offices at Mumbai, Chennai & Kolkata.

2. Further, in order to facilitate the Indian seafarers for a swift & seamless issuance of CDCs, the following corrigenda is now effected in the said DG Shipping Order No. 06 of 2012, mutatis-mutandis;

The work of receipt of applications for processing & issuance of renewal, duplicate & replacement CDCs, however, is hereby decentralized in the offices of the Shipping Masters, Mumbai, Chennai and Kolkata, with reference to the respective original CDCs issued. The three Shipping Masters shall receive applications for renewal, replacement, & duplicate CDCs in respect of the original CDCs issued by them only. The above arrangement shall take effect from 01.01.13. The Shipping Master, GSO, Mumbai, shall, in this light, transfer all applications pending with him	A seafarer holding a CDC initially issued by any of the three Govt. Shipping Offices at Mumbai, Chennai & Kolkata may apply, as per his/her choice, for the issuance of his renewal/replacement/duplicated issuance of CDC to any of the Govt. Shipping Offices at Mumbai, Chennai & Kolkata. The Shipping Master of the Govt. Shipping Office concerned where such an application is received, shall, on the receipt of the same, expeditiously process the case & for an application where the CDC was initially issued any of the other two Govt. Shipping Office(s), the relevant particulars thereof shall be checked by him from the CDC online checker. For those such

email shall be made by him to the Shipping Master concerned who, in turn, shall verify from the available official records in his office & shall confirm by return email within 3 working days latest of such receipt. The CDC shall then be issued expeditiously, online, so as the particulars duplicate/ of renewal/replacement CDC issued are updated in the CDC e-portal (online checker), so that the status of the seafarer concerned can be accessed electronically for counter- checking thereof by the authority concerned.

3. All the other terms & conditions of the said DGS Order 06 of 2012 remain unchanged.
